The colostrum must come from holdings registered in accordance with Regulation (EC) No 852/2004 and checked in accordance with Article 49 and 50 of Regulation (EU) 2019/627.</p> <p>(ii). The colostrum must have been produced, collected, cooled, stored and transported in accordance with the hygiene conditions laid down in Chapter I of Section IX of Annex III to Regulation (EC) No 853/2004.</p> <p>(iii). The country of origin of the colostrum must have a residue monitoring plan approved by GB(§), submitted in accordance with Directive 96/23/EC, providing the guarantees on the residues status or substances covering live animals and products thereof, and in particular Article 29.</p> <p>(iv). The colostrum complies with the maximum residue limits for residues of antibacterial veterinary medicinal products laid down in the Annex to Regulation (EU) No 37/2010, pursuant to testing for residues of antibacterial drugs carried out by the food business operator in accordance with the requirements of point 4 in Part III of Chapter I of Section IX of Annex III of Regulation (EC) No 853/2004.</p> <p>The colostrum has also been produced under conditions guaranteeing compliance with the maximum residue levels for pesticides laid down in Regulation (EC) No 396/2005, and maximum levels for contaminants laid down in Regulation (EC) No 1881/2006.</p>
