The live animal(s) or animal product(s) herein described, complies/y with the relevant Swiss legislation and requirements which have been recognised as equivalent to New Zealand legislation and requirements as prescribed in the Agreement between New Zealand and the Swiss Confederation on Sanitary Measures Applicable to Trade in Live Animals and Animal Products. Specifically, in accordance with 916.443.10 and 916.401.</p> <p>II.2. The animal products are eligible for trade within the European Union without restriction;</p> <p>II.3. The bovine semen complies with provisions of the Bluetongue Chapter of the OIE Code;</p> <p>II.4.
