<p><b>GB requirements</b> for the rabies antibody titration:</p> <p>It must be carried out on a blood sample taken by the veterinarian authorised by the competent authority not less than 30 days after the preceding vaccination and at least three months prior to the date of entry of this certificate, proved an antibody titre equal to or greater than 0,5 IU/ml.</p> <p>It must be performed by a laboratory approved in accordance with Article 3 of Council Decision 2000/258.
