The country of origin of the colostrum must have a residue monitoring plan approved by GB(§), submitted in accordance with Directive 96/23/EC, providing the guarantees on the residues status or substances covering live animals and products thereof, and in particular Article 29. (iv). The colostrum complies with the maximum residue limits for residues of antibacterial veterinary medicinal products laid down in the Annex to Regulation (EU) No 37/2010, pursuant to testing for residues of antibacterial drugs carried out by the food business operator in accordance with the requirements of point 4 in Part III of Chapter I of Section IX of Annex III of Regulation (EC) No 853/2004. <p>The colostrum has also been produced under conditions guaranteeing compliance with the maximum residue levels for pesticides laid down in Regulation (EC) No 396/2005, and maximum levels for contaminants laid down in Regulation (EC) No 1881/2006.</p>
